. Tax Admissibility. (a) The provisions of this section shall be a partial repeal of the provisions of section 38 of Act. (i) Any document showing the nature, character and volume of business of any person becomes admissible in a court of law in favour of any person as evidence of the facts therein stated by the person making the document unless it is proved that the document was made by reason of actual or purported deception or fraud. (b) Any person who makes any document for his own account which relates to the business of another person and which purports to be a true copy of the document of such other person is guilty of an offence and shall be punished as provided in section 70 of this Act. (2) Any person other than a taxpayer who produces a document showing the amount of the income, as shown to him, of any person shall be punishable with fine which may extend to Rs.10.000 and to rigorous imprisonment which may extend to three years. [Act. No.3 of 1962. (3) Every person who gives or offers any security to any other person for the promotion of any trade or business shall be punished with fine which may extend to Rs.2.000 and to rigorous imprisonment which may extend to one year. (4) For the purpose of this section, "business" means the selling, buying, offering, selling, arranging, giving, selling, buying, offering, lending or negotiating of anything in respect of which any person has or has had dealings as principal, agent or broker. * * * * (5) When used in this section, the expressions including and include have the same meaning as in the Indian Contract Act 1872. (6) Notwithstanding anything contained in the Indian Contract Act 1872, no term in the contracts, the contracts of which shall have been duly registered or registered and made parties to the contracts shall be subject to be varied by any provision of any statute or rules made thereunder. 3.
